

## VILLAGE OF PULASKI – BOARD OF REVIEW – MAY 18<sup>TH</sup>, 2016

The Board of Review of the Village of Pulaski met at the Municipal Building on Wednesday, May 18<sup>th</sup> 2016. Village President Reed Woodward called the meeting to order at 4:00 PM and upon roll call the following Trustees were present: Bruce Brzezowski, Roger Brzezowski, Robert Gajewski, Doug Prentice, Chris Smith, Robert Van Lannen, and Reed Woodward. Also present: Attorney Bill Vande Castle, Mike Denor – Assessor – Fair Market Assessments, and Karen Ostrowski – Village Clerk.

**MOTION BY ROGER BRZECZKOWSKI AND SECONDED BY GAJEWSKI** to approve the agenda as presented. **MOTION CARRIED.**

**MOTION BY VAN LANNEN AND SECONDED BY PRENTICE** to appoint Village President Reed Woodward as Chairman of the 2016 Board of Review. **MOTION CARRIED.** (Note: The Board of Review Training – Two-Year Requirement was met for Reed Woodward. Training Requirement met on 05-22-2015 – as per Village Clerk – Karen Ostrowski).

Mike Denor – Assessor, was sworn in by Village Clerk – Karen Ostrowski.

Discussion was held in reference to the 2016 Assessment Rolls for the Village of Pulaski – Brown, Oconto, and Shawano Counties – as per Mike Denor – Assessor. Woodhaven was classified as residential and should have been classified as commercial. It is now changed. Oconto and Shawano Counties stayed the same in total assessment values, and Brown County did go up.
